

Website Terms of Service

These Terms of Use, together with any and all other documents referred to herein, set out the terms of use under which you may use our website at <http://www.firewoodltd.com> ("Our Site").

Please read these Terms of Use carefully and ensure that you understand them.

Your agreement to comply with and be bound by these Terms of Use is deemed to occur upon your first use of Our Site. If you do not agree to comply with and be bound by these Terms of Use, you must stop using Our Site immediately. These Terms of Use do not apply to the sale of services.

1. Definitions and Interpretation

1.1 In these Terms of Use, unless the context otherwise requires, the following expressions have the following meanings:

3. Accounts

3.1 Our Site and applications within them require an Account in order to access and use them.

3.2 You may not create an Account if you are under 18 years of age.

3.3 When creating an Account, the information you provide must be accurate and complete. If any of your information changes at a later date, it is your responsibility to ensure that your Account is kept up-to-date.

3.6 If you close your Account, any information you have created on Our Site will be anonymised by removing your personal details and any specific details which can be used to identify you or your organisation.

4. Intellectual Property Rights

 - 10.2.10 implies any form of affiliation with Us where none exists;
 - 10.2.11 infringes, or assists in the infringement of, the intellectual property rights (including, but not limited to, copyright, patents, trade marks and database rights) of any other party; or
 - 10.2.12 is in breach of any legal duty owed to a third party including, but not limited to, contractual duties and duties of confidence.
- 10.3 We reserve the right to suspend or terminate your access to Our Site if you materially breach the provisions of this Clause 10 or any of the other provisions of these Terms of Use. Specifically, We may take one or more of the following actions:
- 10.3.1 suspend, whether temporarily or permanently, your Account and/or your right to access Our Site;

 - 10.3.3 issue you with a written warning;
